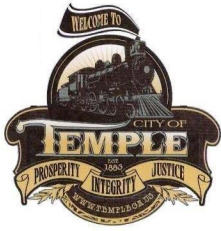

The City of Temple is NOT RESPONSIBLE for any water damage or flooding mishaps that may occur when water is turned on. Customer must be at home to have service turned on. If not at home the lock will be removed from your meter, and you will be responsible for turning on the water. If your water meter is a radio-read meter, there is a cylindrical antenna attached to the meter box lid which can be broken when hit with hard objects such as a lawn mower. You are responsible for damages to this antenna and will be charged \$150 replacement cost if damaged. Water bills are mailed out by the first of each month and considered delinquent if not paid by 4pm on the due date of the 20th. Failure to receive a bill does not absolve you of your payment responsibility.

ANY ACCOUNT PAST DUE WILL BE CUT OFF FOR NON-PAYMENT THE 10TH BUSINESS DAY OF THE FOLLOWING MONTH! If the account is cut off there will be a **\$50 reconnect fee** and the balance on your account paid in full to have services restored.
