1. Hold a public hearing and then consider taking action on the Temple Planning Commission's December 19, 2023, recommendation that the City Council approve the variance request pertaining to the electricity installation methods at the 23.5-acre Azelea Hills Phase 3 residential development on Venable

Road, being Tax Parcel # T02 0110044 in Land Lot 115, District 6. Application by property owner Abdel-Mahdi Al-Husseini.

- 2. Adopt an Ordinance ratifying the FY2024 City of Temple Capital Fund Budget, which was approved by the City Council on December 4, 2023, following the City Council's required second public hearing.
- 3. Adopt an Ordinance ratifying the FY2024 City of Temple General Fund Operating Budget and Water Fund Operating Budget, which were approved by the City Council on December 4, 2023, following the City Council's required second public hearing.
- 4. Approve a 1-1/2 percent cost of living increase effective with the start of the next pay period for all full-time City of Temple employees who have completed their initial probationary employment period.
- 5. Consider accepting one of the three proposals received by the City of Temple for installation of a camera security system at the City of Temple's Wastewater Treatment Plant, with funding from the City's FY2024 Capital Fund budget.
- 6. Review information and then consider authorizing the expenditure of up to \$34,900 from the current funding for the HVAC system in the City of Temple Recreation Department gymnasium by T & T Commercial Services in order to include the building's lobby and rest room areas.
- 7. Authorize the Mayor to sign a staffing agreement with Express Employment Professionals pertaining to one temporary employment vacancy.
- 8. Report concerning the request from The Adell Foundation Peace Center for a one-time use of the Recreation Department gymnasium in the months of January, April, May, and September for its 2024 Wellness Matters "Food and Mood" sessions.
- 9. Approve the City of Temple's 2024 updated list of approved vendors and contractors.
- 10. Discussion followed by adoption of the proposed 2024 Meeting Calendar.
