Planning Commission Meeting December 19, 2023 6:00PM, Temple Senior Center MINUTES

1. Call to Order:

The meeting was called to order at 6:00pm by Chairman, Gary Thomas.

2. Roll Call:

3. Approve the minutes of the November 21, 2023, Temple Planning Commission meeting. There was a motion by Troy Curtis to approve the November 21, 2023, minutes, second by Greg Doster. Vote 5-0.

4. Status report on Council action taken from the November 21, 2023, Temple Planning Commission Meeting.

Assistant City Administrator Lisa Jacobson explained that at the December 4, 2023, Council Meeting, the City Council proceeded with the Planning Commission's recommendation and voted to approve Ridge Cole's rezoning request of his property from OI to R2.

5. Receive information on the request from Mahdi-Al-Husseini for a variance in electricity installation methods at Azalea Hills Phase 3 on Venable Road. Tax Parcel #T02 0110044, 23.5-acre tract of land, land lot 115, district 6.

Assistant City Administrator Lisa Jacobson explained that the Development Code states that electrical should be underground. Mr. Al-Husseni brought it to the City's attention that Carroll EMC recommends that the electrical not be underground. Staff followed up with Carroll EMC and the City's Engineer who both agreed that the electrical does not need to be underground due to the terrain and other issues. It is the recommendation of staff to allow the variance that is being requested.

Mr. Al-Husseni, the applicant, was present at the meeting. He thanked Ms. Jacobson for her explanation and stated it would be almost impossible to put the electrical underground due to the terrain, a retaining wall, a creek that runs along the road, and other issues. He explained that right now the electrical lines are in the right of way and they would re-route them so that they would be further away and not as noticeable. He thanked everyone for their support. There were no questions for the applicant.

6. Hold a public hearing concerning the variance request made by Madhi-Al-Husseni. Chair Gary Thomas opened the public hearing. There was no one present at the meeting to speak for or against this request. The public hearing was closed.

7. Consider taking action concerning the variance request from Madhi-Al-Husseni for a variance in electricity installation methods at Azalea Hills Phase 3 on Venable Road. Tax Parcel # T02 0110044, 23.5 acre tract of land, land lot 115, district 6.

There was a motion by Calvin waters to recommend approval of the variance request by Madhi-Al-Husseni for electricity installation methods at Azalea Hills Phase 3, second by Terron Bivins. Vote 5-0.
